#### *Anti-Hunger Advocate and Aging Insights Guest*

For over a decade, Diane has been a leading voice for the hungry and poor in New Jersey. Joining the Community Food Bank in 2011, Diane led a coalition of stakeholders to raise awareness about hunger, engage in public dialogue, and influence policies that address underlying causes as well as solutions.
